Age Group:

Under 16: Born on/after July 01, 2000

Under 13: Born on/after July 01, 2003

Entry Fee: Rs. 200/- per team

1. Tournament is open to all recognised schools/clubs/academies
2. Age Category – Boys under 13 years; under 16 years
3. In any team, a maximum of three players only of lower age group can play in the higher age group also.
4. Each category to have minimum of 8 teams for commencement of the matches.
5. Each team must furnish names of 11+5 (players + substitutes) and respective jersey numbers.
6. Number of substitutes is 5 and any three substitutions can be used in a game.
7. Teams must report 30 minutes before scheduled match time to sign the register and for briefing. In case a team does not report 10 minutes after the schedule start time, **a penalty kick will be awarded** against the defaulting team. In case of further delay (upto 15 mins), a walkover will be awarded to the opponent.
8. No Pre-game warm-up will be allowed inside the play field before the match starts.
9. No boarding & lodging will be provided to any team, except in the North East Finals.
10. All matches will be played on knockout basis and the duration for U-13 is 40 mins (20+5+20) and U-16 is 50 mins (25+5+25 mins)
11. Players must dress in proper football attire with numbers on both sides of jersey. Shin guards and stockings are compulsory otherwise the player and/or the team may be disqualified.
12. Footwear – Boots with moulded rubber studs or sports shoes only – no bare foot play.
13. Any requests for postponement or changes of match timings will not be entertained.
14. The Chief Referee or organiser may at their discretion, postpone/alter the time of a match due to unavoidable circumstances. If a game stopped in the first 15 mins by officials, the rescheduled game shall be re-played. If stopped after the first 15mins of play, score at the time of stoppage shall be considered.
15. **The decision of the referee is final during the match. No protest will be entertained against referee's decision.** In case of any protest other than referee's decision, the team has to lodge a formal protest signed by the team manager/coach with a non-refundable fee of Rs. 300/- within 30 minutes of the final whistle.
16. In matters of doubt not covered in the tournament rules, the decision of the Tournament Committee (SPT Sports) shall be final and binding on all.
17. For practice, teams have to bring their own balls. For play, ball will be provided.
18. No team to play with fewer than 9 players (incl. goalkeeper) or else game is awarded to the opponent irrespective of the number of goals scored
19. In case of a tie after the allotted time, the match result will be decided by tie-breaker rule.
20. **Tie-Breaker-** Each side will be allowed 3 penalty kicks from penalty mark. In case of a tie, 2 more penalties will be taken by each side. If still a tie, sudden death rule shall apply.
21. Entries must be sent officially with all the players, captain and manager/coach's names appearing and duly signed by the Principal/Secretary/Manager. No changes will be allowed later.
22. If any team walks out of the ground in protest during the playtime, the team will be disqualified from the tournament.

23. If a player is found playing rough or using foul language or misbehaving with referee, a yellow card will be shown, leading to suspension of player for minimum 2 min. If further offence committed by same player, he will be shown red card and debarred from the match and/or suspended from future games (based on the referee's decision). There will be no replacement allowed for this suspension during the match.
24. **Age proof: It is mandatory** to enclose age proof **with photo** - school ID/Birth certificate/Passport with Registration Form for all players and to carry original to venue for verification. **Failing which, the team will be disqualified.**
25. No player will be allowed to play wearing any jewellery like ring, chain, watch, etc.
26. In absence of any clarification, the rules of FIFA will be applicable for the tournament.
27. The Organizer, Sponsor will not be held responsible/liable in case of any injuries to the participants during tournament. Only basic first aid kit will be available at the venue during matches.
28. *Upon agreeing to participate in the event, the participant and the team management agrees that he/they are doing so by their free will and waives SPT Sports, its employees, the sponsors and all associates part of the event, from any liability or claims arising from any loss, injury, untoward incident during the course of the event.*
29. **Organizer has full authority to disqualify any team for indiscipline and improper age proof ****

North East Finals at Guwahati:

> Winning team of each group from each state to be invited for the NE Finals with all expenses of fare and stay paid for.

> **Age proof of each player need to submitted from a qualified doctor with approval from state association. In absence of doctor's certificate, player/team may be disqualified from NE Final.**

NE Finals cash prize: Winner Rs. 72,000/- + Coach Rs. 5,000/- for each category. To be provided as scholarship in two installments to each player of the winning team – Total Rs. 4,500/- per player
